

MAKERS + FIXERS JUNE 2026 CONTEST SPECIAL GIVEAWAY ADDENDUM**

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

This Special Giveaway Addendum (this “**Addendum**”) supplements and modifies the Makers + Fixers Contest Official Rules available at: <https://www.snapon.com/EN/Makers-and-Fixers/Share-Your-Story/Official-Rules> (the “**Official Rules**”).

This Addendum applies only to the Makers + Fixers Contest conducted from **June 1, 2026 through June 30, 2026** (the “**Giveaway Period**”).

By participating, Participants agree to be bound by both this Addendum and the Official Rules. **In the event of a conflict, this Addendum governs solely with respect to the Special Giveaway described herein.**

1. ELIGIBILITY

The Giveaway is open and offered to legal residents of the 50 United States, the District of Columbia, Puerto Rico and all provinces in Canada, excluding Quebec, who are at least the age of majority in their state, territory or province as of the date of entry ("Participant"). Employees, officers and directors of Sponsor, and its parent, each of its affiliates (as used in the Official Rules, "affiliate" means any legal entity controlling, controlled by, or under common control with a party), subsidiaries, advertising, public relations, and Giveaway agencies, Webmasters/suppliers and members of the immediate family (spouse, children, siblings, parents), and persons living in the same household (whether or not related) of any of the above are ineligible. The Drawing Date will be July 1, 2026, with notification sent out to the winner on or about July 8, 2026.

3. ENTRY

All entry methods, requirements, and limitations are governed by the Official Rules and remain unchanged.

4. WINNER SELECTION AND NOTIFICATION

Winner selection, odds, and notification procedures will be conducted in accordance with the Official Rules.

5. SPECIAL GIVEAWAY (OVERRIDES STANDARD MONTHLY GIVEAWAY)

For the Giveaway Period only, the standard Makers + Fixers prizes are replaced with the following:

- Use of event tickets is subject to venue terms and conditions.

8. TAXES

Winner is responsible for all federal, state, provincial, and local taxes associated with acceptance and use of the Prize.

9. PUBLICITY

Except where prohibited, acceptance of the Prize constitutes consent to Sponsor's use of winner's name, likeness, and entry in accordance with the Official Rules.

10. RELEASE AND LIMITATION OF LIABILITY

11. ADDITIONAL REQUIREMENTS
